## EYFS & KS1 Programme Disclaimer

TYG Ltd. recommends adults with medical conditions, physical limitations, or other concerns should obtain clearance from a healthcare professional before engaging in the activities.

Settings must create a safe and conducive environment for the children and adults to engage in the programme. This includes ensuring adequate space, appropriate flooring, and the absence of any hazards that could pose a risk to the children during the sessions.
